

INTRODUCTION

We at IntraLeap Ventures respect your right to privacy and so the purpose of this Website Privacy Policy is to outline how we deal with any personal data you provide to us while visiting the Barita Stock Alerts website (the "Site"). TYPES OF INFORMATION COLLECTED

We collect and retain two types of information:

PERSONAL DATA

NON-PERSONAL DATA

COOKIES
